1. Full amount is due at time of registration. There are no refunds or cancellations.
2. A \$50 service fee per family will be charged for changes made after we have received your registration.
3. Medical forms are due by May 15th regardless of your start date at camp.
4. No refunds will be granted for sick or absent days.
5. No children will be released to a non-family member without knowing the child release password you indicated on the registration form.
6. The legal guardian(s) hereby gives approval and consent for the child's participation in the activities of The Art Farm.
7. The legal guardian(s) understands and acknowledges that his/her child's participation in the activities is completely voluntary and has familiarized him/her with the activities in which hazards and/or dangers are inherent. Accordingly, The Art Farm has taken safety measures to minimize the risk of injury to the participants in such activities.
8. The Art Farm cannot ensure or guarantee that the participants, equipment, premises and/or activities will be free of hazards, accidents and/or injuries.
